1 Conduct physical exam | problem reveal

Having conducted a physical exam, a problem was revealed by the doctor

2 Mr Green | live near hospital | require | treat

Mr Green, who lives near the hospital, requires a treatment.

3 Mr Green = mechanic | work long hours

Being a mechanic, Mr Green works long hours ✓

Mr Green, who is a mechanic, works long hours ✓

4 Mr Smith admit hospital | near house

Mr Smith was admitted to the hospital which is near his house

5 CASE NOTE: bone break dancing| cause fall

He broke his bone while dancing, causing a fall

He broke his leg, which caused a fall

Breaking his leg, he fell

Example:

having conducted an examination on her, a lump was felt in her right breast

Having conducted abdominal examination, Tumor was noted.

Having conducted a physical examination, a tenderness was observed in right upper quadrant of abdomen.

having conducted Blood tests, a high blood sugar level was found

Having conducted ultrasound of the abdomen, a definitive diagnosis was made.
